## SOPHISTICATED INVESTOR DECLARATION

Introduction

介绍

First Prudential Markets Pty Ltd (ABN 16 112 600 281, AFSL 286354, "**FP Markets**") is an independent and privately-owned company providing financial products to Retail, Sophisticated, Wholesale and Institutional Clients. The Company specialises in offering CFDs over equities, futures and forex.

First Prudential Markets Pty Ltd (ABN 16 112 600 281, AFSL 286354, 以下简称"FP Markets")是一

家独立的私营金融服务公司,主要业务是为零售客户(Retail),高阶投资者(Sophisticated),

高净值客户(Wholesale)以及机构(Institutional)客户提供金融交易产品,主要可交易产品为 全球股票,期货和外汇的CFD差价合约,

The Corporations Act 2001 (Cth) ("**Corporations Act**" or "the **Act**") allows for the issue of financial products to a client without a Product Disclosure Statement ("**PDS**") where the client is a "wholesale client" within the meaning of section s 761G of the Corporations Act. One category of wholesale clients under the Corporations Act are "sophisticated investors", who are clients that meet the criteria set out in s 761GA of the Act.

In short, a sophisticated investor is someone who FP Markets is satisfied on reasonable grounds has previous experience in using financial services and investing in financial products that allows them to assess:

FP Markets applies a stringent test to satisfy itself of the matters above. At minimum, you will need to meet the following criteria:

If you wish to be treated as a sophisticated investor you will be asked to provide some or all of following documentation to support this classification: 如果您申请高净值客户评估,您需要提供以下信息:

- Recent Payslip showing annual salary or most recent tax return summary 近期工资单,需要可以表明年收入;或者近一年的个人缴税单;
- Certificate from your accountant stating your assets of at least \$500,000 AUD 您的会计师出具的资产证明文件,表明您的净资产不低于50万澳元,会计资质需要满足澳大利亚 会计准则;
- Documents demonstrating your trading history from FP Markets trading account/s 您在FP Markets的历史交易记录;
- Statement/s for the previous 5 years demonstrating your trading experience, whether from FP Markets or another reputable broker;

- Employment contract from a financial services business.

If FP Markets determines that I am eligible for classification, you will be provided with a written statement containing FP Markets' reasons for being satisfied as to the criteria in s 761GA. 如果通过FP Markets的评估,您确实符合高阶投资者标准,FP Markets将会为您提供一份书面的通知来说明您满足澳大利亚公司法 (The Corporations Act 2001) 第 s 761G 条款的依据。

By signing this Sophisticated Investor Declaration form, I warrant that I have requested FP Markets to consider my previous experience for the purpose of classification as a sophisticated investor under s 761GA of the Corporations Act.
